# CHIEF FINANCIAL OFFICER'S REPORT

# Dear Fellow Unitholders,

2019 represented the first full year of operations for the three (3) segregated portfolios (hereafter, "Fund" or "Funds"), having been officially launched to the public in November 2018. Prior to November, the Funds' assets represented the initial investment from the Trinidad and Tobago Unit Trust Corporation (TTUTC), which was invested in accordance with the objective of each Fund. The transactions between the Funds and TTUTC are fully described in the audited financial statements.

As the Funds are in their nascent phase, investors should factor in the absence of scale when assessing their performance.

# UTC Global Investor Select ETF Fund Segregated Portfolio - Conservative

The Fund's Total Assets grew 38%, moving from \$844 to \$1,166 owing principally to cash proceeds from new subscriptions during the period, together with favourable fair value movements of \$53 on the Fund's investment securities. Cash and Cash Equivalents declined by \$383 when compared to 31st December 2018 as these surplus funds were invested during the period.

Net income improved from a loss of \$12 to a profit of \$50 owing substantially to the reversal of unfavourable fair value movements in 2018 of \$29 to a favourable \$53 in 2019. Dividend income improved by \$13 in 2019 owing to investment portfolio growth, while expenses increased by \$20 arising from increased activity when compared to 2018.

# UTC Global Investor Select ETF Fund Segregated Portfolio - Moderate

The Fund's Total Assets grew 70%, moving from \$887 to \$1,509 owing principally to cash proceeds from new subscriptions during the period, together with favourable fair value movements of \$65 on the Fund's investment securities. Cash and Cash Equivalents declined by \$385 when compared to 31st December 2018 as these surplus funds were invested during the period.

Net income improved from a loss of \$12 to a profit of \$62 owing substantially to the reversal of unfavourable fair value movements in 2018 of \$33 to a favourable \$65 in 2019. Dividend income improved by \$19 in 2019 owing to investment portfolio growth, while expenses increased by \$24 arising from increased activity when compared to 2018.

# UTC Global Investor Select ETF Fund Segregated Portfolio - Aggressive

The Fund's Total Assets grew 38%, moving from \$857 to \$1,181 owing principally to cash proceeds from new subscriptions during the period, together with favourable fair value movements of \$52 on the Fund's investment securities. Cash and Cash Equivalents declined by \$480 when compared to 31st December 2018 as these surplus funds were invested during the period.

Net income improved from a loss of \$16 to a profit of \$48 owing substantially to the reversal of unfavourable fair value movements in 2018 of \$39 to a favourable \$52 in 2019. Dividend income improved by \$12 in 2019 owing to investment portfolio growth, while expenses increased by \$20 arising from increased activity when compared to 2018.

### THE FUTURE

The Funds have operated according to their respective investment mandates, with their 2019 results reflecting the short-term market performance of the securities held. Investors are encouraged to maintain long-term horizons for their investment decisions.

# ECONOMIC AND CAPITAL MARKET REVIEW

# Global

Heightened uncertainties and volatility dominated the global capital markets over most of 2019. Trade policy uncertainty, geopolitical tensions, and idiosyncratic stress in key emerging market economies weighed heavily on global economic activity in the second half of 2019, particularly in terms of manufacturing and trade. By the end of the year, however, most of these uncertainties receded, providing some impetus to the financial markets. The reduced uncertainties stemmed from: tentative signs that both manufacturing activity and international trade were bottoming out; a general return to more accommodative monetary policies by the world's central banks: signs of a potential resolution to the ongoing trade impasse between the US and China; and the dissipation of 'No-Deal' Brexit-related fears that characterised most of 2019 following the landslide electoral victory by the UK's Conservative Party.

The International Monetary Fund (IMF) reports that global growth is estimated to have decelerated to 2.9% in 2019 from 3.6% in 2018. The slowdown was broad-based, occurring across the major advanced economies, as well as emerging market and developing economies, which grew by 1.7% and 3.7% in 2019 respectively, compared to 2.2% and 4.5% in 2018.

The IMF estimates US real gross domestic product (GDP) growth for 2019 of 2.3%, down from 2.9% a year earlier. The US Federal Reserve Open Market Committee (FOMC) met on December 10th–11th and maintained the federal fund's target range of 1.50–1.75%. The IMF estimates the UK's economic growth

at 1.3% in 2019. Real GDP growth slowed to 1.1% in the third guarter of 2019 in the UK, from 1.2% in the second quarter amid weaker global growth and heightened Brexit-related uncertainties which both weighed on consumer spending. The IMF estimates economic growth for the Euro Area at 1.2% in 2019. Economic activity in the Euro Area continues to be subdued with real GDP growth confirmed at 1.2% year-on-year at the end of the third guarter of 2019, unchanged from the previous quarter. The Chinese economy grew by an estimated 6.0% in the fourth quarter of 2019, unchanged from the previous quarter, amid persistent trade pressure from the US and sluggish domestic and overseas demand for goods and services. This marks the slowest pace of growth recorded since the first quarter of 1992. The IMF estimates Chinese economic growth for 2019

The global equity markets performed well, evidenced by a 25.2% price return on the MSCI World Index and a 28.9% return on the US S&P 500 Index in 2019. US stock market volatility declined significantly in 2019 with the Volatility Index (VIX) falling to 13.8 by the end of 2019 from 25.4 at the end of 2018.


Global fixed-income markets benefitted from the broad-based switch to more accommodative monetary policies by many of the world's central banks which exerted downward pressure on global bond yields, and favourably impacted fixed-income portfolio valuations. The de-escalation of trade tensions between the US and China towards the year's end, coupled with weak global Purchasing Managers' Indices (PMIs) and benign inflation, all contributed to the conducive fixed-income environment. These factors contributed to the return of 6.8% for the Barclay's Global Aggregate Index (LEGATRUU) in 2019.

<sup>\*</sup> The Volatility Index (VIX) is a real-time market index representing the market's expectations for volatility over the coming 30 days. The VIX is often referred to as the 'fear gauge' of the financial markets. As an example, in October 2008 during the height of the Global Financial Crisis, the VIX measured 89.5, exemplifying the high level of expected volatility in the financial markets at that time.



Global real estate markets also performed well in 2019 with the MSCI World/Real-Estate Sub-Index recording a net return of 26.07% in 2019. Supportive underlying global financial conditions have helped to boost investor appetite and underpinned capital flows into real estate markets.

# **Review of Fund Performance and Strategy**

The three (3) Funds under review are:

- 1. Global Investor Select ETF Funds: Aggressive
- 2. Global Investor Select ETF Funds: Moderate
- 3. Global Investor Select ETF Funds: Conservative

The GIS ETF Funds were officially launched in November 2018 with the UTC investing seed capital in the amount of US\$750,000 in each Fund. As outlined in the Fund's prospectus, the primary objective is to achieve long-term growth over a full market cycle through diversification of the portfolio into ETFs which represent different market sectors. The sector allocations are determined using a proprietary optimisation process. This asset allocation strategy is complemented using a tactical momentum-based risk management strategy aimed at downside risk protection.

For the year ended December 2019, the three (3) Funds produced positive net returns to Unitholders as follows: Conservative Fund: 4.7%, Moderate Fund: 4.4% and Aggressive Fund: 4.3%. Aggregate fund

size grew by 49.2% from US\$2.5Mn to US\$3.8Mn, bolstered by net sales during the year of US\$1.1Mn. Total income of US\$0.3Mn in 2019.

All of the Funds' ETF holdings also posted positive returns in 2019. The top-performing ETFs in the approved security universe on a price return basis assuming full investment over the one-year holding period included: Vanguard REIT ETF (VNQ), SPDR S&P 500 ETF (SPY), Invesco Powershares QQQ Trust (QQQ) and Vanguard FTSE Developed ETF (VEA) which produced price returns of 24.4%, 28.8%, 37.8% and 18.8% respectively. VNQ belongs to the Real Estate component, SPY and QQQ belong to the US Equity component and VEA to the Global Equity component.

The worst-performing ETFs on a price return basis assuming full investment over the one-year holding period included: iShares iBoxx \$ Investment Grade Corp Bond ETF (LQD), iShares 7-10yr Treasury Bond ETF (IEF), iShares Core US Aggregate ETF (AGG) and iShares Short Treasury Bond ETF (SHV) which generated price returns of 13.4%, 5.8%, 5.5% and 0.2%, respectively. These ETFs all belong to the Fixed-Income component.

On a technical basis, VNQ surpassed its 200-day dividend-adjusted moving average in February 2019 and remained above it over the remainder of the year. SPY and QQQ initially broke above their respective 200-day dividend-adjusted moving

averages in March 2019 before the prices dipped in June 2019 and thereafter resumed their upward trajectory, outpacing their respective moving averages for the remainder of 2019. VEA momentarily broke past its 200-day dividend-adjusted moving average in April 2019 but fluctuated around its 200-day dividend-adjusted moving average over the ensuing six (6) months (May to October) before once again surpassing the 200-day dividend-adjusted moving average over the rest of 2019.

The Funds generally maintained their respective positions in LQD, IEF, AGG and SHV over the course of 2019.

### **MACROECONOMIC OUTLOOK FOR 2020**

Since its initial outbreak in Wuhan, China in December 2019, the novel coronavirus (COVID-19) was declared a pandemic by the World Health Organization (WHO), spreading to a total of over 200 countries at the time of writing. So far, there have been close to 7.6Mn confirmed cases of COVID-19 worldwide, with the current death toll over 422,000. The US, Italy, Spain and Germany have all surpassed China in terms of the total number of confirmed COVID-19 cases. With a mortality rate of roughly 5.1%, COVID-19 does not appear to be as deadly as that of the SARS epidemic of 2003 with a mortality rate of 7.2%, although COVID-19 has proven to be far more contagious. Some of the likely negative spillover effects of COVID-19 include sharp

reductions in consumer spending as individuals seek to maintain social/physical distancing by avoiding crowded public spaces such as shopping malls, mass transit and public transportation, restaurants and cinemas. Additionally, businesses may likely face increased manpower and productivity challenges as infected and other at-risk individuals go into quarantine.

In response to the pandemic, many governments around the world have implemented various containment measures, including temporary closure of schools and non-essential businesses, and travel restrictions in an attempt to slow the spread of the virus. There is therefore now a much greater probability of a global recession, but it is hoped that any such recession would be relatively short-lived, paving the way for at best a partial recovery in the second half of 2020 or at worst mid-to-late 2021. At a joint World Bank IMF press conference to address the COVID-19 response on 4th March 2020, IMF Managing Director Kristalina Georgieva indicated that global growth in 2020 would now likely fall short of the 2.9% growth rate achieved in 2019, and further commented that the exact extent of the shortfall would be heavily dependent on the timeliness and effectiveness of the various countermeasures implemented to contain the spread of COVID-19. The latest forecasts from Capital Economics, one of the world's premier economics research companies. point to a 1% contraction in global economic growth in 2020.



pandemic.

Amid the increased concerns over the fate of the global economy, the global financial markets were not left unscathed. In March 2020, the US stock market entered a bear market with the benchmark S&P 500 Index declining by 25.4% as at 2nd April 2020 since its peak on 19th February 2020. With respect to the fixed-income markets, barring additional financial support from world governments to help offset mounting operational costs, the economic fallout from COVID-19 is expected to cause financial distress and place increased pressures on both sovereign and corporate credit quality.

In early March 2020, global oil prices plummeted to lows not seen in nearly 20 years, following a breakdown in Organisation of Petroleum Exporting Countries (OPEC) negotiations regarding proposed production cuts intended to stabilise prices in the face of weakened global demand associated with the COVID-19 pandemic. The current financial market turmoil has weighed on investor sentiment, prompting an outflow of investment capital from equities and riskier securities into safe-haven assets, particularly US treasuries and gold. The current environment has, however, presented new potential investment buying opportunities, particularly in the US equity space.



Other looming risks and uncertainties include renewed geopolitical tensions in the Middle East (notably between the US and Iran), further deterioration in international trade relations, mounting political and social unrest, the ongoing US presidential race and the outcome of the upcoming November 2020 US general election, all of which may affect the trajectory of global economic growth over the short to medium term.







# 1 General information

UTC (Cayman) SPC Ltd. (the "Company") was incorporated on 4 September 2015 as an exempted segregated portfolio company, with limited liability, under the provisions of the Companies Law (Revised) of the Cayman Islands. Its registered office is situated at Campbells Corporate Services Limited, 4<sup>th</sup> Floor, Willow House, Cricket Square, P. O. Box 268, Grand Cayman KY1-1103, Cayman Islands.

The Company is a wholly owned subsidiary of the Trinidad and Tobago Unit Trust Corporation (the "Corporation"), an entity established by the Unit Trust Corporation of Trinidad and Tobago Act, Chapter 83:03 of the Laws of the Republic of Trinidad and Tobago. The Corporation manages the investments and trading activity of the Company, under an Investor Advisory Agreement and is also the Sponsor, Administrator and Investment Advisor. The Corporation's registered office is UTC Financial Centre, 82 Independence Square, Port of Spain, Trinidad and Tobago.

The Company was licensed on 1 October 2015 as a mutual fund under Section 4(1)(a) of The Mutual Funds Law (2015 Revision) of the Cayman Islands by the Cayman Islands Monetary Authority. The Company operates as three (3) open-ended mutual funds regulated by the Cayman Islands Monetary Authority and the Trinidad and Tobago Securities and Exchange Commission, namely:

- UTC Global Investor Select ETF Fund Segregated Portfolio Conservative
- UTC Global Investor Select ETF Fund Segregated Portfolio Moderate
- UTC Global Investor Select ETF Fund Segregated Portfolio Aggressive

### **Authorised share capital**

UTC (Cayman) SPC Ltd is authorised to issue two classes of shares – management shares and segregated portfolio shares. The management shares are voting, non-participating, non-redeemable shares. The segregated portfolio shares, referred to as participating shares hereafter, are redeemable, non-transferrable shares with limited voting rights and no pre-emptive rights or rights of conversion or exchange. Voting rights of participating shares are limited to meetings held to determine the variation or abrogation of the rights attaching to participating shares.

The authorised share capital of the Company is US\$50,000 divided into 100 management shares of US\$1 nominal value each and 499,000,000 participating shares of \$0.0001 nominal value each designated on issue as either:

- a Global Investor Select ETF Fund SP Conservative share
- a Global Investor Select ETF Fund SP Moderate share
- a Global Investor Select ETF Fund SP Aggressive share

On 4 September 2015, 100 fully paid up management shares were allotted and issued at par to the Trinidad and Tobago Unit Trust Corporation which remained the legal and beneficial owner of the 100 management shares at 31 December 2019.

# Participating shares

Participating shares are redeemable at the holder's option at prices based on the net asset value (NAV) per share of the respective segregated portfolio. Each segregated portfolio's NAV per share is calculated by dividing the net assets attributable to participating shareholders of the segregated portfolio by the total number of participating shares outstanding. In accordance with the provisions of each segregated portfolio's Offering Memorandum, securities are valued based on the last traded market price for the security.

Redemptions take place on redemption days and may be subject to a Redemption Fee. A redemption day is generally any day that banks are authorised to open for business in Trinidad and Tobago and New York City. Participating shares are carried at the redemption amount that is payable by the segregated portfolio at the reporting date if a holder exercises the right to put the share back to the respective segregated portfolio.

# Initial pricing

The Initial Offer Price for participating shares in each segregated portfolio was set at \$20.00 per share. The Initial Offer Price applied for the Initial Offer Period – 26 November 2018.

### Subsequent pricing

Subsequent to the Initial Offer Period, subscriptions and redemptions took place on a forward pricing basis. On any day on which there are subscriptions or redemptions, the Investment Advisor arranges for the NAV per participating share to be determined in accordance with the Offering Memorandum of each segregated portfolio. In particular, the NAV of each segregated portfolio is determined at the valuation time. The normal valuation time is approximately two (2) hours after the close of business of the Stock Exchanges in New York on any business day.

All subscription orders received before the close of the US Stock Markets and all redemption orders received before 12 noon Atlantic Standard Time, are processed at the NAV per participating share, determined at the valuation time for that day.

# 2 Summary of significant accounting policies

The principal accounting policies applied in the preparation of these financial statements are set out below.

### a. Basis of preparation

The financial statements have been prepared in accordance with International Financial Reporting Standards (IFRS). The financial statements have been prepared under the historical cost convention, as modified by the revaluation of financial assets at fair value through profit or loss. The methods used to measure the fair value of the segregated portfolios' financial assets are provided in Note 2 e. (iii).

The preparation of financial statements in conformity with IFRS requires the use of certain critical accounting estimates. It also requires the Board of Directors to exercise its judgement in the process of applying the accounting policies. There were no areas involving a high degree of judgement, or assumptions and estimates that were significant to the financial statements.

### b. Standards and amendments to existing standards effective 1 January 2019

There are no standards, amendments to standards or interpretations that are effective for annual periods beginning on 1 January 2019 that have a material effect on the financial statements of the segregated portfolios.

# c. New standards, amendments and interpretations effective after 1 January 2019 and have not been early adopted

A number of new standards, amendments to standards and interpretations are effective for annual periods beginning after 1 January 2019 and have not been early adopted in preparing these financial statements. None of these are expected to have a material effect on the financial statements of the segregated portfolios.

# d. Functional and presentation currency

The segregated portfolios' primary activities are conducted in United States Dollars including: receipts for subscriptions and redemption of participating shares. The performance of the Fund is measured and reported to the investors in United States Dollars.

Accordingly, the Board of Directors considers the United States Dollar as the currency that most faithfully represents the economic effects of the underlying transactions, events and conditions and has designated the United States Dollar as the segregated portfolios' functional and presentation currency.

- e. Financial assets at fair value through profit or loss
  - (i) Classification

### Assets

The segregated portfolios classify its investments based on both the segregated portfolios' business model for managing those financial assets and the contractual cash flow characteristics of the financial assets.

The investment assets of the segregated portfolios are held in portfolios which are managed and performance is evaluated on a fair value basis. The segregated portfolios are primarily focused on fair value information and uses that information to assess the assets' performance and to make decisions. The segregated portfolios have not taken the option to irrevocably designate any equity securities as fair value through other comprehensive income. The receipt of contractual cash flows and the purchase and sale of the financial assets in the portfolios, are incidental to the objectives of the investment portfolios. Accordingly, the investment assets in the segregated portfolios have been classified and measured at fair value through profit or loss – mandatory.

# (ii) Recognition, derecognition and measurement

Regular purchases and sales of investments are recognised on the trade date – the date on which the segregated portfolios commit to purchase or sell the investment. Financial assets at fair value through profit or loss are initially recognised at fair value.

Financial assets are derecognised when the rights to receive cash flows from the investments have expired or the segregated portfolios have transferred substantially all risks and rewards of ownership.

Subsequent to initial recognition, all financial assets at fair value through profit or loss are measured at fair value. Gains and losses arising from changes in the fair value of the 'financial assets at fair value through profit or loss' category are presented in the statement of comprehensive income within net changes in fair value of financial assets at fair value through profit or loss in the period in which they arise.

Dividend income from financial assets at fair value through profit or loss is recognised in the statement of comprehensive income within dividend income when the segregated portfolios right to receive payments is established.

### (iii) Fair value estimation

Fair value is the price that would be received for an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value of the segregated portfolios' ETFs – which are all traded in active markets – is equal to the quoted market prices for identical assets at the close of trading on the reporting date (or the last trading day before the reporting date) where the closing price is within the bid-ask spread which is most representative of fair value.

A significant movement in fair value is any movement that materially affects the integrity of the closing price for an ETF where the movement occurs after the close of the market - but before completion of the daily computation of the segregated portfolio's NAV. The segregated portfolios are valued after the daily close of the Stock Exchanges in New York.

The segregated portfolios use a fair value hierarchy to rank the fair value of their financial assets. The fair value of a financial asset is categorised into one of three levels based on the degree to which the fair value inputs are observable. The three levels are:

Level 1 which represents valuations based on unadjusted quoted prices for identical assets in active markets that the segregated portfolios can access.

Level 2 which represents valuations based on inputs that are other than quoted prices included within Level 1 that are observable for the financial asset either directly or indirectly.

Level 3 which represents valuations based on inputs that are unobservable for the financial asset.

The level in the fair value hierarchy within which the fair value measurement is categorised in its entirety, is determined on the basis of the lowest level input that is significant in the valuation of the financial asset.

The determination of what constitutes an observable input requires judgement. The segregated portfolios consider observable data to be market data that is readily available, regularly distributed or updated and verifiable, not proprietary and provided by independent sources that are actively involved in the relevant market.

(iv) Transfers between levels of the fair value hierarchy

Transfers between levels of the fair value hierarchy are deemed to occur at the beginning of the reporting period.

# f. Offsetting financial instruments

Financial assets and liabilities are offset, and the net amount reported in the statement of financial position, when there is a legally enforceable right to offset the recognised amounts and there is an intention to settle on a net basis or realize the asset and settle the liability simultaneously. There were no financial instruments subject to offsetting arrangements at the reporting date.

### g. Receivables from shareholder

Receivables represents amounts due from the shareholder in respect of subscriptions. These amounts are recognised initially at fair value and subsequently remeasured at amortised cost. At each reporting period the segregated portfolios shall measure the loss allowance on amounts due from the Shareholder at an amount equal to the *lifetime expected credit losses* if the credit risk has increased significantly since initial recognition. If at the reporting date, the credit risk has not increased significantly since initial recognition, the segregated portfolios shall measure the loss allowance at an amount equal to 12-month expected credit losses.

Significant financial difficulties of the shareholder, probability that the shareholder will enter bankruptcy or financial re-organisation, and default in payments are considered indicators that a loss allowance may be required. If the credit risk increases to the point that it is considered to be credit impaired, interest income will be calculated based on the gross carrying amount adjusted for the loss allowance. A significant increase in credit risk is defined by management as any contractual payment which is more than 30 days past due. Any contractual payment that is more than 90 days past due is considered credit impaired.

# h. Cash and cash equivalents

Cash and cash equivalents include cash in hand, deposits held at call with banks and other short-term investments in active markets with original maturities of three months or less.

# i. Dividend income

The segregated portfolios invest exclusively in ETFs and cash and cash equivalents.

Dividend income is recognised when the right to receive the dividend is established.

### j. Transaction costs

Transaction costs are costs incurred to acquire financial assets. They include fees and commissions paid to agents, advisers, brokers and dealers. Transaction costs, when incurred, are included in the cost of the financial asset on initial recognition.

### k. Taxation

There is, at present, no direct taxation in the Cayman Islands. The Company is also the holder of tax concessions whereby, for a period of twenty years ending on 12 October 2035, the Government of the Cayman Islands undertakes that with respect to the Company: no law imposing any tax to be levied on profits, income gains or appreciation shall apply to the Company or its operations; and no tax will be levied on profits, gains or appreciations nor will tax (which is the nature of estate duty or inheritance) be payable in respect of any of the shares, debentures or other obligations of the Company, nor will tax be withheld in whole or in part in respect of any relevant payment as defined in Section 6(3) of the Tax Concessions Law (2011 Revision).

By virtue of the tax concession the interest, dividends and gains payable by the segregated portfolios are free of any Cayman Island taxes for the next sixteen years.

The segregated portfolios are required however to pay the applicable withholding tax on dividends, interest and other income received from other tax jurisdictions.

Any income distribution paid by the segregated portfolios to residents of other tax jurisdictions will be subject to the tax laws of their jurisdiction of residence.

The segregated portfolios are also required to withhold and remit taxes to the authorities of certain jurisdictions based on distributions made to their citizens.

### 3 Financial risks

# a. Financial risk factors

The segregated portfolios' activities expose it to a variety of financial risks: market risk (including price risk), liquidity risk and credit risk.

The segregated portfolios are also exposed to operational risks such as custody risk. Custody risk is the risk of loss of securities held in custody occasioned by the insolvency or negligence of the custodian. Although an appropriate legal framework is in place that eliminates the risk of loss of value of the securities held by the custodian, in the event of its failure, the ability of the segregated portfolios to transfer securities might be temporarily impaired.

The overall risk management program of the segregated portfolios seeks to:

- maximise the returns derived for the level of risk to which the segregated portfolios are exposed; and
- minimise potential adverse effects on the segregated portfolios' financial performance.

The management of these risks is carried out by the Investment Advisor applying policies, rules and principles approved by the Board of Directors including:

- the construction of a diversified portfolio of non-correlated assets that collectively have a lower risk than any individual holding.
- the use of an optimisation process that identifies the best percentage allocation to the different asset classes of each segregated portfolio so as to increase the probability of achieving the expected risk and return targets.
- the restriction of investments to either ETFs (with no derivative exposure) or cash and cash equivalents.
- The restriction of the maximum exposure of the segregated portfolios to any one ETF to 10% of the segregated portfolios' assets.
- A restriction on the voting securities held by a segregated portfolio in any one issuer. (A segregated portfolio may not acquire an ETF if, after purchase, the segregated portfolio would control more than 10% of the voting securities of the issuer).

The segregated portfolios use a number of methods to measure and manage the various financial risks to which it is exposed.

# (i) Price risk

The segregated portfolios invest in ETFs which are listed instruments that seek to track the investment results of specific indices. ETFs are susceptible to market price risk due to uncertainties about the future values of their underlying assets.

Uncertainty of the future value arises from the performance of the underlying securities and, where the ETFs are denominated in other currencies, in the possibility that there would be adverse movements in the exchange rates used to translate the prices of securities denominated in foreign currencies.

The segregated portfolios' policy is to manage price risk through diversification of the portfolio, careful selection of securities, the use of a tactical momentum methodology and restrictions on the proportion of a segregated portfolio's assets that may be invested in any one ETF.

The momentum strategy used is a simple 200 day moving average. If the moving average calculation of an ETF in the portfolio is above its 200 day moving average at the close of the last trading day of the month, then the asset remains invested. If not, it is liquidated and the proceeds are held in cash.

Credit risk is the risk that one party to a financial instrument will cause a financial loss for the other party by failing to discharge an obligation.

# b. Capital risk management

The capital of the Company is represented principally by the segregated portfolios' assets. The value of the assets can change significantly in the event of significant market volatility which directly impacts the segregated portfolios' performance.

The segregated portfolios' objective when managing capital is to safeguard their ability to continue as going concerns and maintain a strong capital base to support the development of their investment activities.

The Board of Directors and Investment Advisor monitor capital on the basis of the value of the assets of the segregated portfolios.
